- 3. Please note:
- 1) For the 1st and 2nd audition, a piano accompanist should be arranged by the applicant. If it is difficult to arrange, you can use the NHK SO piano accompanist.
- 2) Those who pass the document screening will be notified by <u>Friday, June 13th, 2025.</u> No telephone inquiries will be accepted.
- 3) The successful candidates from the first audition will be notified by Thursday, July 3rd, 2025.
- 4) All individual expenses for the audition shall be borne by applicant.
- 5) Submitted documents (résumé and letter of recommendation) are non-returnable.
 After the screening and auditions, submitted documents by all applicants except those of a successful applicant shall be shredded and disposed with caution.
- 4. How to apply
- 1) Résumé(Application form) including your name and current address, date of birth, contact details (mobile phone number and email address where you can be reached during the daytime), history of study (names of teachers studied under), professional career, awards received, as well as your reason for applying for the audition and a recent photo.
- 2) A letter of recommendation (no format is specified, but it should be written after January, 2025. If you submit a hand-written letter in a language other than Japanese, please attach a typed version.)

The NHK Symphony Orchestra (Public Interest Incorporated Foundation) will properly handle personal information entrusted to us during the recruitment screening process as follows based on Japanese laws and regulations.

1. Purpose of use:

Personal information entrusted to us will be used for the purpose of receiving and keeping record of your application, and contacting you regarding the notification of screening and hiring results. In the case you are hired, we will use it for the purpose of employment and personnel labor management. Unless otherwise specified, we will acquire only the minimum necessary items for business. Submitting personal information is voluntary, but we would like to have your understanding that it may affect the screening process.

Personal information additionally received during the recruiting process is also subject to the same treatment stated above.

2. Provision of information to third parties

Except as stipulated by law, we will provide none of your personal information whatsoever to third parties without your consent. During the screening process, there may be a case in which we will consign part of our operations to a third party entity within the scope necessary to achieve the purpose of use shown in Clause 1 above.

3. Management of personal information

Your personal information will be strictly managed. Please note that the necessary documents submitted to us will not be returned. The personal information of unsuccessful applicants will be disposed of at our
